Notice is hereby given that at a regular meeting of the Planning Commission of the City of Mountain Brook, Alabama, to be held on November 5, 2012, at 5:30 p.m. in Council Chambers at Mountain Brook City Hall, 3928 Montclair Road, Suite 230, Mountain Brook, Alabama, said Planning Commission will hold a public hearing to consider a proposed amendment to Chapter 129 of the Code of the City of Mountain Brook, **adding new “Vine Street Transitional” zoning district and amending Article XXXI (Village Overlay Standards) and Section 129-416 (Advisory Design Review Required in the Villages of Mountain Brook)**, as further described in the draft ordinance appended to this notice, additional copies of which are available for inspection and copying in the Assistant City Clerk's office at City Hall. At the aforesaid time and place, all persons who desire shall have an opportunity to be heard in opposition to or in favor of adoption of the proposed amendment.

**\*\* No actual properties are to be REZONED in conjunction with these zoning ordinance amendments; however, a new zoning district is proposed to be added to the zoning ordinance. If such ordinance is adopted, property owners along Vine Street (those highlighted in yellow on the attached map) would have the opportunity to apply for rezoning to the Vine Street Transitional (VST) zoning district on an individual basis. Any such future rezoning would require public hearings by the Planning Commission and City Council with notification of property owners within 500 feet of any such property requesting to be rezoned to VST.**

At the aforesaid time and place, all persons who desire shall have an opportunity to be heard in opposition to or in favor of adoption of the proposed amendment.

Any such future rezoning would require public hearings by the Planning Commission and City Council with notification of property owners within 500 feet of any such property requesting to be rezoned to VST.**
