# MINUTES OF THE SPECIAL MEETING OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN BROOK, ALABAMA AUGUST 30, 2022

The City Council of the City of Mountain Brook, Alabama met in special public session on Tuesday, the 30th day of August 2022, at noon. The meeting was then called to order by the Council President and the roll was called with the following results:

# 1. CONSIDERATION OF A RESOLUTION (NO. 2022-129) CANVASSING THE RESULTS OF THE AUGUST 23, 2022 GENERAL MUNICIPAL ELECTION (APPENDIX 1)

**WHEREAS**, the general election for the City of Mountain Brook was duly and legally held on Tuesday, August 23, 2022, as provided by law, and

**WHEREAS**, the municipal governing body of the City of Mountain Brook met on this 30th day of August 2022, a quorum thereof of being present, at noon, and has canvassed the returns, and has ascertained and determined the number of votes received by each candidate, and

**WHEREAS**, said municipal governing body has ascertained and determined the results of said election summarized as follows [Appendix 1]:

- 1. Graham Smith received a majority of the votes cast for the office of City Council Place No. 1 and is hereby declared duly elected to that office for the five (5) year term beginning on the first Monday in November 2022.
- 2. William S. "Billy" Pritchard III received a majority of the votes cast for the office of City Council Place No. 3 and is hereby declared duly elected to that office for the five (5) year term beginning on the first Monday in November 2022.
- 3. Lloyd C. Shelton received a majority of the votes cast for the office of City Council Place No. 5 and is hereby declared duly elected to that office for the five (5) year term beginning on the first Monday in November 2022.

It was moved by Council Member Garner that the resolution canvassing the election results be passed. The motion for adoption of the resolution was seconded by Council Member Womack and upon the question the vote thereon was as follows:

Council President Smith thereupon declared that said resolution (no. 2022-129) is adopted by a vote of 5—0 and as evidence thereof she signed the same and the elected officials issued a certificate of election (Appendix 1).

- There was an unprecedented historic turnout in Mountain Brook for the municipal election
- More people voted in the Municipal Election than on Super Tuesday 2020 (in the Republican and Democratic primaries combined)
- Graham Smith, Billy Pritchard, and Lloyd Shelton won their races by almost a 3-1 margin.
- Felt Billy Pritchard, Graham Smith and Lloyd Shelton conveyed a message that a strong selfconfident community is one that listens to all voices and does not shrink from challenges

- Congratulated Billy Pritchard, Lloyd Shelton and Graham Smith on their victories
- Congratulated the voters of Mountain Brook who won the battle for the soul of the community, proving that civility, competence and mutual respect are still alive in Mountain Brook
