# TREE COMMISSION RECOGNIZED

The Tree Commission is very pleased to announce that Mountain Brook has been recognized as a Tree City USA for the 18th consecutive year by the National Arbor Day Foundation. This award requires a member city to have an active tree board or commission, an Arbor Day program, an official policy dealing with trees and vegetation, and a city forestry budget of at least \$2 per capita. In reality, the city well exceeds the minimum standards.

Mountain Brook also became a "Sterling Tree City" in January, after receiving a 10th consecutive Growth Award. To qualify, the City must show measurable progress in one or more categories related to community forestry. Some activities that have helped secure the award in past years include hiring a full-time city forester, improving the Arbor Day seedling giveaway and associated school programs, successful grant applications to conduct various forestry operations, and the initiation and subsequent expansion of the annual Christmas tree recycling event with the Birmingham Zoo--now in its 5th year.

This prestigious designation has been earned through dedication to the continued management of the community's tree resource and the commitments that dozens of volunteers, the Tree Commission, and a succession of council members have made over the last ten years. Here's to ten more!

# CITY ELECTION IN AUGUST

Mark your calendars for Tuesday, August 28, 2012 when the City's residents will vote to fill the Mayor's office and two council seats. The following seats are up for election:

Each of these incumbents is expected to run for re-election. Other candidates may qualify to run for these seats between July 3-17. Residents should expect to receive post cards in August informing them of their polling location.

#### OTHER PERTINENT DATES ARE AS FOLLOWS:

**July 17**...... Last day to qualify to run for municipal office (due on or before 5 p.m.). Forms are available from the City Clerk.

**August 10**..... Last day for a resident to register as a qualified elector for the August 28, 2012 general municipal election.

**August 23**...... Last day for a voter to apply for a regular absentee ballot. Last day to file the 5-10 day pre-election campaign disclosure form with the Probate Judge. Last day to publish the list of qualified voters.

**August 27......** Last day for a voter to apply for an emergency absentee ballot (for persons required by their employer to be out of town on election day). Voting machines are to be sealed. Absentee ballots, if mailed, must be postmarked by August 27. Hand delivered absentee ballots must be received by 5 p.m.

August 28..... Election day.

# MOUNTAIN BROOK PUBLIC WORKS NEWS

#### REMEMBER IT'S MOSQUITO SEASON.

The City's Mosquito Control Project starts in April with us putting out briquettes. We will begin fogging the right of ways in May.

Remove all standing water from around your property (tree holes, lily ponds). Clean out clogged gutters. Mosquitoes will use any source of standing water available to breed.

For more information on mosquito control visit the Jefferson County Department of Health's website, (www.jcdh.org) search word is "Vector Control" phone 205-933-9110.

#### TRASH PICKUP

Loose-leaf pickup service has ended for this season. All loose leaves and small trash items will have to be containerized for curbside collection.

Larger trash items should be on the curb for the knuckle-boom truck collection. Work done by a contractor is not eligible for pick-up by Waste Management.

#### **SPECIAL ITEMS DISPOSAL**

**Paint cans** – Remove the lids from all of the cans. If there is paint inside, put sand, dirt, or kitty litter in the cans with the paint for absorption. Place the cans curbside with the lids off for pick-up.

**Appliances with Freon** – have the Freon removed. A certified sticker has to be placed on the item before it will be picked-up.

Our compost operation is in full swing. We load open-bed vehicles Monday through Thursday from 7:00 a.m. until 11:00 a.m. and in the afternoons between the hours of 1:00 p.m. to 4:00 p.m. Call our office (205-802-2390) if more information is needed.

# A PARK ON THE CAHABA

The City of Mountain Brook has acquired a parcel of beautiful open space on the Cahaba River at the intersection of Overton Road and River Run Road. The four and one half acre wooded lot has great views of the river, easy access to the water's edge, and a generous tree buffer to the traffic on Overton Road. The land was previously owned by Brookwood Baptist Church, but has been used by many locals as a canoe launch, picnic area, fishing spot, and swimming hole.

Nimrod Long and Associates was retained by the City to prepare a conceptual master plan for the property and its future as a park. After the first site visit, Nimrod Long, the firm's President, realized the natural beauty of the land would only require a light touch in order to preserve and accentuate the best features. Large hardwood trees, flowering trees and shrubs and a thin understory layer allow unobstructed views through the site, similar to a park setting. The gentle slope down to the river from Overton Road is an easy walk and levels off in terraces that are perfect for staging the park amenities.

The conceptual plan was developed with input from the Park Board over several months and then presented to the public at a town hall meeting in February. At these meetings, Mr. Long acknowledged that the Cahaba River is the park's main attraction and the challenge is to provide multiple ways to enjoy the river while minimizing impact on the land. The design accomplishes this task by minimizing paving areas and leaving large areas of existing vegetation intact. Invasive exotic plant species will be removed and replaced with trees, shrubs, and grasses that are native to Alabama.

The plan (see image) includes an outdoor classroom area, walking trails, picnic pavilion, fishing ledge, bioswale, and small parking lot. The outdoor classroom is located at the north end of the site near a rocky shoal and will accommodate small groups on boulder seating near the river's edge. A paved six foot wide trail forms a loop through the site and connects the parking area to the river's edge and all the planned amenities. Gravel trails spur off the main loop and lead down to the river to access the fishing ledge and outdoor classroom. A bioswale will collect water from the parking lot and passively treat the water, removing pollutants before it returns to the Cahaba.

One important function of the park is as the trailhead for a future greenway that would follow the Cahaba River for two miles up to the Carraway-Davie House and access a large tract of land owned by the Freshwater Land Trust. This greenway would have spectacular views of the river and would quickly become one of the region's most popular natural areas. A blueway (for canoes and kayaks) would parallel the greenway along this same stretch of river, with access points on Old Overton Road and the park site. The blueway and greenway are included in the Red Rock Ridge and Valley Trail System, the master plan for a trail system throughout Jefferson County.

Although there is not a timeline for construction, the City is considering ways to raise funds to build the park within the next few years. If you have comments or suggestions for the park, please contact the City Manager at gastons@mtnbrook.org or 802-3800.

# **IMPROVING 9-1-1 RESPONSE TIME FROM CELL PHONES**

Time is critical when responding to emergencies. Time works against you when you must react in an emergency and time works against emergency responders in the event of a fire or medical emergency.

Anything that adds time to responding units in an emergency reduces the opportunity for good outcomes. Your Fire Department is continually searching for ways to keep response times to a minimum.

We have noted over the last several years that delays in 911 notification are due primarily to the increased use of cell phones in reporting emergencies to the 911 system. Dialing 911 from a cell phone does not assure that the correct responding jurisdiction receives the call. Cell phones connect to the closest cell tower for the particular phone service company and if that cell tower is in another jurisdiction, then the call has gone to the wrong system and the emergency response will probably be delayed or possibly dropped.

There are a couple of processes to use which can help reduce or eliminate these problems. One is to pre-program or set up a speed dial for the City of Mountain Brook Dispatch Center using our seven digit emergency number (870-5580). This will get you directly to the appropriate emergency services center if you are in the City of Mountain Brook. Another helpful process is to immediately tell the 911 dispatch center that answers the call that you are in the city of Mountain Brook. They will then transfer your call to our dispatch center if they are another jurisdiction.

If you are dialing 911 from an in-house, hard-wired phone, then it will go directly to the appropriate 911 center; however, if you are dialing from a cell phone, please consider the above options. It will help us help you more expediently. Please remember in our business time is life, and time is property.

# **CODE CHANGES TO MAKE YOUR HOME SAFER**

A local building contractor has posed the question: "The City of Mountain Brook has adopted some new codes that require buildings to have their smoke detectors upgraded during remodeling. What is this requirement?"

The City of Mountain Brook currently enforces the 2009 International Residential Code published by the International Code Council. There has been very little change from the 2003 to the 2009 code requirements for smoke alarms. New homes, or homes when work requiring a permit occurs, smoke alarms are required in each sleeping room, outside each separate sleeping area – in the hallway outside the bedrooms, and on each additional story of the home including basements and livable attic space. The Code also requires that where more than one smoke alarm is

needed, the alarms must be interconnected so that the actuation of one alarm will activate all of the alarms in the home.

The major change found in the 2009 International Residential Code is the requirement for carbon monoxide alarms. Carbon monoxide alarms are now required outside of each separate sleeping area in the immediate vicinity of the bedrooms – in the hallway outside the bedrooms – when the home has fuel-fired appliances installed or where the home has an attached garage. These requirements apply in a new home or when work requiring a permit occurs in an existing home.

Early detection and residential fire sprinklers are the keys to surviving a fire in your home. If you have any questions, please contact the Mountain Brook Fire Department at 205-802-3838.

ogy related classes. If you are a savvy internet user you might already know about our downloadable audio and ebooks available through Overdrive. We've also added a new database called Books 24x7 which offers popular non-fiction titles in a wide variety of topics from personal computing and wireless devices (think how to use your iPhone!) to books on personal finance and consumer health. If you're a music fan, we offer Freegal, a music download service which provides three downloads per week for Mountain Brook residents. Another great service is Rocket Languageswhich enables you to learn languages as diverse as Spanish, Arabic, Chinese, and French. You may be familiar with Rocket Languages, their entry level programs are free to anyone, but the Library subscribes to a more in-depth program.

With so many resources at hand, the Library will be providing classes for our patrons to learn about what we offer.
