MUNICIPAL ELECTION

The general municipal election is scheduled for Tuesday, August 23rd, 2022. Offices up for election include: 1) City Council Place 1 (currently held by Alice Womack), 2) City Council Place 3 (currently held by William "Billy" Pritchard), and 3) City Council Place 5 (currently held by Lloyd Shelton).

The qualification period ended June 28th, 2022. The following residents (listed by office alphabetically by last name) qualified for the open offices:

- Place 5: Tate Davis Lloyd Shelton

Mountain Brook residents are assigned by the Jefferson County Board of Registrars to polling locations based

on congressional districts. To minimize confusion by voters, Mountain Brook has adopted the same poll assignments used by the County (meaning residents generally vote in their "customary" polling location).

The six polling locations for the City election are as follows:

- St. Luke's Episcopal Church
- City Hall
- · Brookwood Baptist Church
- · Mountain Brook Community Church
- · Canterbury United Methodist
- · Cherokee Bend Elementary

It is each voter's responsibility to update their voter registration at the Jefferson County Board of Registrars' office. The last day to register to vote for the municipal election is August 8th, 2022.

The purpose is to avoid the possibility of having all new council members who may lack experience in municipal governing.

The learning curve is steep, so I think our decision (many years ago) to have split elections was a wise one.

Being a member of the city council is a volunteer position that demands a minimum of 500 hours per year. It takes a lot of dedication to serve on the city council. The quality of the council members determines the future of our city, so this election is very important.

Each of the three open council seats has multiple candidates, so I strongly encourage you to get to know the candidates and determine, for yourself, who will best serve the residents of the City of Mountain Brook. Be looking for the notice from the Mountain Brook Chamber of Commerce for their "Get to Know the Candidates" event on August 16 from 6:00 pm – 7:30 on the City Hall lawn. Your vote matters.

Garbage Service Changes

mwaste will begin providing garbage service Amwaste will begin providing garbage service for the City beginning October 1, 2022. Following are some highlights of what to expect from our new collections provider:

- · There will be two collections weekly at the curb. Collections will be performed Monday through Saturday.
 - ✔ Bagging debris before placing inside the 95-gallon cart is recommended. Bagging minimizes the chances of spillage and results in cleaner containers which reduces odors and the risk of pests.
 - ✓ The first collection may include both household waste and recycling. Materials collected in the first pick-up will be taken to RePower South where recyclables will be separated from the household waste. Please do not place loose yard waste in the first collection as yard waste inhibits the RePower South's ability to sort the recycling from garbage.
- ✓ The second collection may include household garbage and small bagged bulk brush and other yard waste. Everything collected in the second pick-up will be taken to the landfill.
- Materials should be taken to the curb by 6:30 a.m. on your collection day. Routes begin at 7 a.m.

Carts will be delivered no later than the last week of September. Should you need/ desire more than one cart (for a fee), you may contact Amwaste. More information will be provided later.

- The curbside carts will be machine lifted/ emptied likely from the passenger side of the garbage truck.
 - ✓ Carts should be placed within three feet from
 - ✓ Because carts are collected from the passenger side only, collection times for the right side of a street may vary by up to several hours from the left side of the same street for routing efficiency.
- ✓ Do not place carts on sidewalks, storm drain covers, gutters, steep slopes, under lowhanging utilities lines or other obstructions or within six feet of fixed objects (e.g., mailboxes, hedges, parked vehicles, utility poles, etc.)
- ✓ Carts/single bags may not exceed 50 pounds.
- Backdoor collection will no longer be a standard service provided. However, the service will be offered on an elective subscription basis paid quarterly by the homeowner.

- ✓ The cost of backdoor collection will be \$28.14 quarterly (*to be indexed for inflation effective October 1, 2022) and will be billed directly by
- ✓ If you would like to register your home for backdoor collection, please access the Mountain Brook back door service survey/ registration on the Amwaste website by August 12, 2022: www.amwaste.net/ mountain-brook-back-door-survey Please input all requested information to the drop-down questions in the survey. You will receive a response email when successful registration has been completed.
- ✓ Residents may sign-up for (or discontinue) backdoor service at any time.
- ✔ The customers with backdoor service will be served by separate route crews using smaller
- ✓ Yard debris should be placed at the curb.
- Regarding recycling, nearly everything is recycled other than food and organic waste. RePower South transforms approximately 70% of waste into solid commodities (baled and sold to established commodity markets) or ReEF fuel which is used as a replacement for coal in industry and energy utility boilers.

- · Debris and bulk collection:
- ✓ There is not a designated bulk trash pick-up day with Amwaste. Small bulk trash may be placed at the curb for collection on the second pick-up of the week. Bulk piles may be no larger than 3 cubic yards.
- ✓ Only homeowner generated materials will be collected. Debris from contracted work must be removed by the contractor.
- ✓ Small hand piles of yard debris should be bagged and placed in the cart for the second weekly pick-up. If too large to fit in the cart, place small hand piles beside the cart for
- ✓ Limbs and branches may not exceed six feet in
- ✓ Place materials no more than three feet from the curb.
- ✔ Cross ties (railroad ties) will not be collected as they are not accepted by landfills.
- ✓ Refrigerated appliances require a Freon removal tax issued by a certified technician.
- ✓ Bulk piles larger than 3 cubic yards will generally be picked-up by knuckle-boom trucks that run continuously throughout the City on a 10-day cycle.

· Leaf collection

- ✔ Bagged leaves will be collected along with debris and bulk collections placed at the curb.
- ✓ Loose leaves placed at the curb will be collected by City crews.





TREE BASICS

Tree Watering Tips for Summer

ONE OF THE MOST FREQUENT QUESTIONS people have during the warm summer months is, "How should I be watering my trees?" While every tree is going to have specific considerations (like species, location, and soil type), here are some general guidelines to keep your trees happy throughout the summer.

Do I Need to Water Now?

There's a simple step you can take to see if your tree needs water. Using a long screwdriver with a minimum 6-inch blade, probe into the ground in several locations under the drip line (the furthest edge of the tree's canopy).

If you are having difficulty probing to a 6- to 8-inch depth and natural rainfall is not in the forecast, then you should begin a watering regime.

Young Trees

New trees, or those planted within the past two years that have trunks less than 1 inch in diameter, should be watered much more frequently than older trees. Aim for two to three times per week. If you are using a garden hose, water the tree for about one minute to ensure a deep soaking.

Older Trees

Established trees, or those two years and older, usually don't need to be watered quite as often. Aim for once a week or every other week, depending on how the soil is retaining moisture.

More Tips

After watering, the soil around your tree should be damp, not soggy. If a puddle remains afterwards, or the tree's leaves are wilting and turning yellow, you may be overwatering it.

Mulch retains water and helps keep roots moist. During drought conditions, consider adding more mulch around the base of your tree.

Compost Is Still Available

The City of Mountain Brook Public Works Department still has plenty of compost available for your gardening needs. Although spring is our busiest season for compost sales, the fall of the year is also a good time to add compost to your garden and other planted areas.

The city recycles the loose leaves collected each year in the Fall and Winter. The loose leaves will be collected this year by our Public Works crews as a service to the citizens. The leaves will then be dumped at the Public Works facility at 3579 East Street, Mountain Brook Alabama, near Rathmell Soccer complex. (use Birmingham if entering into GPS) The leaves are pushed into piles, turned, and as a result of decomposing,

become compost, a useful gardening byproduct of the leaves.

Citizens of Mountain Brook may come to the Public Works facility and receive the compost at no charge if they load themselves. Public Works employees will load them mechanically for a fee of \$20.00 per pickup load. Non-residents may purchase the compost for \$15.00 if they load themselves. We will load them for \$20.00 per pickup load or \$30.00 per scoop to load larger trucks.

The compost operation is available Tuesday through Friday 7:00 am - 11:00 am and 1:30 pm - 3:30 pm. If you have questions regarding compost you may contact Mountain Brook Public Works at (205) 802-2390.

Electronic Recycling and Paper Shredding Event

The City of Mountain Brook held its 2nd annual recycling day featuring secure paper document destruction and electronic waste removal. The event took place on April 23rd, 2022 at Mountain Brook High School from 9 am to 1pm. The City was happy to partner with Gone For Good, a program of the local non-profit United Ability, to service the event. The event featured a volunteer effort including city employees, The Chamber of Commerce, Leadership Mountain Brook and the Kiwanis Club of Homewood/Mountain Brook.



There was a great turnout for this event with over 15,000 pounds of paper and 19,000 pounds of electronics being dropped off for disposal. This event has been a huge success with Mountain Brook citizens continuing to prove our community's commitment to sustainable practices over the last two years. The city plans to continue to offer this service every spring moving forward.

Please Doo Your Part! Bag it and dispose of it. Bagged waste left lying on the ground is just as bad, or worse, than leaving waste. Even though the bags the city provides are biodegradable, it does not mean they

can be used to litter our parks and sidewalks. Please keep our city safe and beautiful.

Dogs are welcome to visit any of the three dog parks in Mountain Brook: Cahaba River Walk southern end of Mountain Brook Elementary field, and the Lane Parke Apartments by Watkins Branch.

City Budget Update

Based on the fiscal 2022 collections reported through May, operating revenues are projected to be \$46 million for the year ending September 30, 2022, compared to \$43.8 million budgeted. Some of the more notable revenue and collection observations include:

- General sales taxes are projected to be \$13.6 million compared to the budget of \$12.2 million. Sales tax collections are up by 15% for the eight month period ended May compared to the same period last year.
- Sales tax collections for online sales administered by the State are projected to be \$1.3 million (almost \$100,000 more than budgeted).
- Business license fees are projected to be \$3.3 million for the year (\$546,000 more than budgeted).

• Construction permit fees are projected to be \$1.4 million for the year (almost \$400,000 more than budgeted)

The 2023 budget development began on May 26 with a City Council work session. Departmental budgets were submitted to the Finance Director in mid-June. The City Manager conducted the first review of the budgets with department supervisors during July. The Finance Committee will review the second draft of the budget on August 18. The City Council will also review the budget and Finance Committee recommendations on August 25. The public hearing to consider the ordinance adopting the 2023 budget is tentatively scheduled for September 26. For more information, please visit the City's website (www.mtnbrook.org).

Gifted Child Find Notice

Intellectually gifted children and youth are those who perform at or have ■ demonstrated the potential to perform at high levels in academic or creative fields when compared with others of their age, experience, or environment. These children and youth require services not ordinarily provided by the regular school program. Children and youth possessing these abilities can be found in all populations, across all economic strata, and in all areas of human endeavor.


Teachers, counselors, administrators, parents or guardians, peers, self, or any other individuals with knowledge of the student's abilities may refer a student to the Student Support Team for consideration for placement in the enrichment program. Additionally, all second grade students are observed as potential gifted referrals using a gifted behavior checklist and referred to the Student Support Team as appropriate.

For each student referred, information is gathered in the areas of aptitude, characteristics, and performance. This information is entered on a matrix where points are assigned according to established criteria. The total number of points earned determines if the student qualifies for the enrichment program.

Opecial education services for children with Odisabilities are provided in accordance with the Individual with Disabilities Education Improvement Act, Amendments of 2004 and Alabama Act 106. Under the Mountain

The O'Neal Library is excited to announce that best-selling novelist, Jeff VanderMeer, will be visiting Mountain Brook on Saturday, September 17. One of the most acclaimed authors of speculative writing today, VanderMeer is the latest author in the *Under the Mountain* series which celebrates the strange and uncanny in literature and films.

Jeff VanderMeer hails originally from Pennsylvania but spent much of his formative years in the Fiji Islands, where his parents worked for the Peace Corps. He later relocated to Gainesville, Florida and then attended Florida State University. In the late 80's, while still a high school student, VanderMeer began writing for small-press magazines and self-publishing his own stories. Considered an exciting new voice in "Weird Fiction", VanderMeer achieved widespread acclaim with his Southern Reach trilogy, the first of which, *Annihilation*, won the Nebula and Shirley Jackson Awards for best novel, and in 2018 was adapted into a major motion picture directed by Alex Garland, starring Natalie Portman and Jennifer Jason Leigh.

VanderMeer's most recent cycle of fiction—Borne, The Strange Bird and Dead Astronauts—demonstrates what the author does best: creating mysterious and perilous worlds where nature and technology run amok, and then populating these unstable ecosystems with compassionately realized characters who, regardless of how vibrantly alien or monstrous as they may seem, all yearn to understand what it means to be that elusive quality we call "human".

VanderMeer resides in Tallahassee, and, alongside his own fiction, is a frequent editor of science fiction and horror anthologies, as well as a contributor to the likes of *The New York Times*, the *Guardian*, Vulture, Esquire.com, and *The Los Angeles Times*.

Under the Mountain will host the author's visit on September 17 at 7:00pm at O'Neal Library. A Q&A and signing will follow with Thank You Books on site to sell books. This event is free and open to the public, but registration is encouraged via the Library website because seating is limited. 


