### **SUMMARY**

City of Mountain Brook Emergency Communications District Jefferson County, Alabama October 1, 2012 through September 30, 2014

The City of Mountain Brook Emergency Communications District, Jefferson County, Alabama, (hereinafter referred to as the "District") was established pursuant to the *Code of Alabama 1975*, Section 11-98-2, and is responsible for providing emergency communication services in the City of Mountain Brook. This includes the operation and administration of duties for which they were elected or appointed, which includes, but is not limited to: (1) To establish, operate, maintain, and replace an emergency communication system; (2) To establish a common addressing and location identification program; and (3) To establish the emergency service number data base to facilitate efficient operation of the system.

This report presents the results of an examination of the District and a review of compliance by the District with applicable laws and regulations of the State of Alabama in accordance with the requirements of the Department of Examiners of Public Accounts under the authority of the *Code of Alabama 1975*, Section 41-5-14, and the *Code of Alabama 1975*, Section 11-98-6(e).

Findings are numbered and reported by the examination period in which the finding originally occurred.

An instance of noncompliance with state and local laws and regulations and other matters was found during the examination as shown on the Schedule of State and Local Compliance and Other Findings and it is summarized below.

#### **CURRENT FINDING**

• 2014-001 relates to failure to submit financial information as required by *Code of Alabama 1975*, Section 11-98-13.1.
