

ORDINANCE NO. 2104

**AN ORDINANCE ESTABLISHING ENTERTAINMENT DISTRICTS
IN THE HISTORIC VILLAGES OF MOUNTAIN BROOK**

WHEREAS, the Legislature of the State of Alabama enacted Act No. 2021-214 to authorize the City of Mountain Brook, Alabama to establish entertainment districts within the historic villages of the City of Mountain Brook, designated as Crestline Village, English Village and Mountain Brook Village, as those districts are defined in the Mountain Brook City Code; and

WHEREAS, pursuant to the terms and provisions and conditions of Act No. 2021-214, the City Council wishes to establish entertainment districts for the purpose of regulating the sale and consumption of alcoholic beverages as provided herein below.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOUNTAIN BROOK, ALABAMA, as follows:

SECTION 1. Under the authority granted in Act No. 2021-214 of the Alabama Legislature, there shall be hereby established the Crestline Village Entertainment District, the English Village Entertainment District and the Mountain Brook Village Entertainment District, with the areas and boundaries as set forth and designated in Exhibit A, attached hereto and made a part hereof.

SECTION 2. Any licensee who receives an entertainment district designation for an on-premise retail license from the Alabama Alcoholic Beverage Control Board shall comply with all laws, rules, and regulations which govern its license type, except that the patrons, guests or members of that licensee may exit that licensed premises with open containers of alcoholic beverages and consume alcoholic beverages anywhere within the confines of the Entertainment Districts but may not enter another licensed premises with open containers or closed containers of alcoholic beverages acquired elsewhere.

SECTION 3. No licensee who receives an entertainment district designation shall allow alcoholic beverages to be removed from the licensed premises in bottles or glass containers.

SECTION 4. Except for special events as permitted by the Alabama Alcoholic Beverage Control Board and in compliance with all laws, rules, and regulations, no alcoholic beverages purchased outside of the Entertainment District shall be allowed in open containers in the Entertainment District.

SECTION 5. Alcoholic beverages may be sold at licensed premises and consumed within the entertainment district designation boundaries during the following days and hours:

- a. Sunday through Wednesday from Noon to 9:00 P.M.
- b. Thursday through Saturday from Noon to 11:00 P.M.
- c. For Special Events approved pursuant to the Event Permit Application process, such hours designated in the Event Permit, if different from those set forth above.

SECTION 6. This Ordinance shall become effective upon passage, approval and publication or as otherwise.
