4. Case P-20-06: 400/402 Office Park Circle, Bradford & Sons/Mouron Family II, LLC EXHIBIT 1

Michael Mouron recused himself from participating in this case.

Request for approval of the installation of a solar energy system consisting of a roof mount array.

Kathy Henderson, Eagle Solar and Light, 4005 2nd Avenue South, Birmingham, presented the application:

- The solar panels will be installed on the flat roof on the existing commercial buildings.
- The solar panels and racking will be installed at a 5 percent tilt on the roof and will not extend more than 7.25 inches from the surface of the roof.
- No part of the roof-mounted system will extend beyond the edge of the roof.
- The panels and system are designed to blend into the architecture of the building.
- No portion of the solar energy system will be visible from any public street. Building 400 is on a hill.
- Any visible electrical lines and conduit will be painted or blended to match the color of the roof.

Amend master development plan for Cherokee Bend Elementary School to allow renovation of the multi-use fields.

Cole Williams and Dale Brasher, Goodwyn Mills and Cawood, presented the application. Mr. Brasher:

- Demolition of existing perimeter fencing, batting cases, lighting and backstops.
- Improvements include: (The full plan is attached to these minutes.)
 - 1. A prefabricated, two-toilet, restroom facility that will aesthetically complement the character of the neighborhood and is similar to the facility recently installed at Mountain Brook Elementary School.
 - 2. LED lighting
 - 3. Bermuda natural grass playing surface
 - 4. Seven 15' tall black vinyl chain-link fence backstops
 - 5. Black vinyl chain-link perimeter fencing, four feet in height.

Mrs. Smith Graham asked if the school is aware of the presented improvements. Mr. Williams replied that representatives from the school, the Parks and Recreation Department and the City participated in all meetings. The future improvements at Cherokee Bend Elementary are mostly interior and will not conflict with the presented project. The consensus is that the improvements will increase usability of each site.

Mr. Black asked if the restroom facility is prefabricated as indicated in the submittal, because it appears to be site-built concrete block. The restroom facility at the Mountain Brook Elementary facility was precast and delivered to the site. Mr. Brasher said that the building will be erected on site using a prefabricated kit.

Mr. Black asked for confirmation of the number of light poles to be removed. Mr. Williams said that nine poles will be removed and seven new LED poles will be added. The new lighting will improve the overall lighting situation and manage light pollution.

Mr. Lassiter asked if the facility will be on the sewer system. Mr. Williams said that they will tie in to the sewer system.

There were no public comments. Mr. Walker called for a motion.

Doyle's Resurvey, being a resurvey of Lot 11 and the West ½ of Lot 12, according to the survey of Map of Colonial Hills Morrow Sector, as recorded in Map Book 18, Page 91, in the Probate Office of Jefferson County, Alabama; situated in the Southwest quarter of Section 4, Twp-18S, R-2W, Jefferson County, Alabama.
