**Sign type:** façade signs, wall sign, and directional signage

**Illumination:** silhouette illuminated letters

Aggregate square footage proposed: 54.53 total square feet

Letter/logo height: 16 inch letters, 40 7/8 inch logo

Variances requested: none

Denise Hensley, Snyder Signs, Inc., presented the application.

Mr. Blackmon stated that the lighting color temperature should be no greater than 3500 degrees Kelvin. Also, the existing sign at the rear should be removed.

Ms. Hensley stated that the customer is debating on the color for the letter set on the existing front wall, blue or dark gray. The committee agreed that either color would be fine.

Motion: Mr. Blackmon: Motion to approve the sign application as submitted, with the

following conditions:

• The lighting color temperature is 3500 degrees Kelvin maximum for all signage, all signs being the same.

- The existing sign at the rear is removed.
- Blue or dark gray may be used for the existing front wall letter set.
